The Bank invites for sealed BID documents for supply of Checkpoint Security Gateway Appliances and Checkpoint Security Management Server along with Licenses to Nepal SBI Bank Ltd. from interested firms/companies meeting the undernoted eligibility criteria along with Firm/Company Registration Certificate, PAN/VAT Registration Certificate, Tax Clearance Certificate & Audit Report and related certificate(s)/letter(s)/document(s) evidencing past work experience.

**Eligibility Criteria for Service Provider:**

- a. Bidder should be in a business of supply, installation, configuration, maintenance and support of networking equipment for at least **5 years** and should be authorized distributor/reseller of Checkpoint products in Nepal and should be a legal entity in Nepal.
- b. Bidder must have an average turnover of minimum **Rs. 5.00 Crore** during last 2 financial year(s).
- c. Bidder should provide MAF.
- d. Bidder should not have been Blacklisted/ Sanctioned or terminated by competent authority or regulatory body during the last 5 years.
- e. Bidder should supply suitable supply Checkpoint firewall and management server as per the Bank's technical requirement. The OEM should give an undertaking that the proposed model should not be EOS or EOL for at least 5 years from the date of delivery.
- f. Bidder should have at least valid CCSA certified technical team and/or firewall support team in the payroll for providing the solution/support in the proposed product model promptly.
